- Complete regulatory filings with federal and state agencies, including IRS, DOL, PBGC and other regulatory agencies
- Oversee annual plan audits and non-discrimination testing
- Consult with internal and external counsel to ensure compliance and adoption of best practices
- Organize quarterly committee meetings
- Ability to meet highest attendance requirements
