A strong focus will be on the various methods of adult learning to ensure that each person has the maximum opportunity to succeed. The overall goal of this role is to assure the highest quality for each participant and plan-level client request while assisting in creating and supporting an effective environment of employee engagement and employee development. The Senior Trainer will provide feedback to both individual processors and management related to individual absorption, personal interactions and performance from the first day of training and continuing through the life of the training. The Senior Trainer will partner with all Group Retirement teams including the quality assurance team, training team, client care center, client forms team, implementation, ongoing services and project teams to ensure appropriate communication and partnership to achieve optimal participant and plan sponsor satisfaction while supporting employee retention and engagement.
